<u>RECRUITMENT FOR FILLING UP OF VACANT POSTS OF PROFESSOR / ASSOCIATE</u> <u>PROFESOR / ASSISTANT PROFESSOR / SENIOR RESIDENT / TUTOR IN DDMCH, KEONJHAR</u>

Eligible candidates are invited to attend the Walk in Interview for the post of Professor / Associate Professor / Assistant Professor / Senior Resident / Tutor in Dharanidhar Medical College & Hospital, Keonjhar on Dt. 12.08.2024 on contractual / deputation basis except for MBBS tutors who will be recruited contractually. The details of eligibility criteria/vacancies are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for one year renewable for a maximum period of four years for the post of Professor, Associate Professor & Assistant Professor. For the post of Senior Resident & Tutor, the engagement shall be purely temporary and for one year. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack, or PGIMER & Capital Hospital, Bhubaneswar either on contractual /deputation basis are eligible to apply for the next higher post only. The regular faculties of any Govt. Medical College of the state, VIMSAR, Burla or AHPGIC Cuttack or PGIMER & Capital Hospital are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years. The reporting time for the above walk-in-interview is from 9.00AM-12 Noon.

1. AVAILABLE VACANCY

Provisional Vacancy is enclosed in separate sheet and subject to change as on the date of counselling.

2 ELIGIBILITY AND QUALIFICATIONS FOR SENIOR RESIDENTS / TUTOR:

2.1 For the post of Tutor, a candidate must possess a MBBS Degree or equivalent degree recognized by MCI/NMC from MCI/NMC permitted / approved / recognized institution or as may be notified by MCI/NMC from time to time. The candidates must have completed the compulsory one year rotating internship.

- 2.2 For the post of Senior Residents in broad specialty, the candidate must possess MD / MS / DNB or any equivalent degree in concerned discipline applied for or as may be prescribe by OMES rules / NMC Minimum Qualifications for teachers in Medical institutions Regulations 2022 from time to time in force.
- 2.3 For the post of Tutor, candidates with Post Graduate degree in concerned subject will be preferred over the MBBS candidates. If candidates with MBBS not available, Medical MSc. in concerned subject (Anatomy, Physiology and Biochemistry) with PhD will be taken.
- 2.4 Selection will be strictly on the basis of merit list prepared on basis of career marks.Weightage for different examinations shall be as under:

HSC/Matriculation-Intermediate Science-MBBS examination-60% of total percentage of marks secured.

- 2.5 One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.
- 2.6 All Qualifications as on the date of interview shall be considered.
- 2.7 Reservation applicable as per Govt. of Odisha, H&FW Department Resolution No.
 18582/H Dt. 13.08.2020 and Govt. of Odisha, H&FW Department Resolution No.
 8967/H Dt. 25.04.2022

Other eligibility conditions:

1. The candidate must be a citizen of India.

2. The Medical Graduates must have registered their medical qualification at Central / State Medical Council (Permanent Registration).

3.The candidate must not be continuing / have completed the tenure as SR / Tutor in any Govt Medical College of the State.

4. The candidate whose service as SR / Tutor has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for reengagement.

5.Age: Must be less than 45 years as on the date of interview.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

3 ELIGIBILITY & QUALIFICATION FOR ASSISTANT PROFESSOR

- 3.1 The candidate must possess MD/MS/DNB/DM/M.Ch or equivalent degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges and/or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" as amended from time to time. Candidates having MSc (Medical Subject) with PhD in pre and para clinical subject (approved by NMC or MCI) may be considered if sufficient candidate with PG degree / DNB are not available and subject to the limitations as may be prescribed by NMC / MCI from time to time. The candidates having DM/M.Ch/DNB or equivalent degree are not required any additional teaching experience.
- 3.2 Must have registered himself/herself under any Central / State Medical Council after obtaining the degree (Permanent Registration).
- 3.3 Must have one year of Teaching Experience Certificate as SR/Tutor in the concerned subjects after completion of PG Course.
- 3.4 The above qualifications must have obtained on or before the date of interview.
- 3.5 The Selection of Asst. Professor will be strictly on the basis of merit list prepared on basis of career marks as these are purely temporary and tenure-based engagements and done only to meet the exigency, on regular recruitment of faculty by the OPSC or on completion of the contractual tenure, whichever is earlier, they shall be disengaged. Weightage for different examination shall be as under:

HSC/Matriculation-	20% of total percentage of marks secured
Intermediate/+2 Science-	20% of total percentage of marks secured
MBBS/M.Sc. examination-	60% of total percentage of marks secured

In case of candidates who have passed PG in 2016-17 and afterwards, MBBS/M.Sc. Examination -30%, PG -30%

One mark will be deducted from the total career mark for each extra attempt taken to pass the examination.

In case of tie it will be resolved as follows:

- i. The candidate securing more mark in MBBS/M.Sc. as the case may be shall be placed in higher rank.
- ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- 3.6 **AGE LIMIT:** The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4 ELIGIBILITY & QUALIFICATION FOR ASSOCIATE PROFESSOR

- 4.1 Must have possessed MD/MS/DNB/DM/M.Ch/MDS or equivalent degree in the concerned specialty. Must have Academic Qualification as prescribed by NMC/MCI from time to time in force. Teaching experience for such number of years as Assistant Professor in the subject in the recognized Medical College, with minimum of such numbers of Research Publication, during the tenure of Assistant Professor or any such other eligibility criteria, as may be prescribed by NMC/MCI as the case may be from time to time.
- 4.2 Must have post PG teaching experience for five years including four years as Assistant Professor in the concerned discipline and in any MCI/NMC permitted / recognized institute with at least two Research Publications as per NMC/MCI Teachers Eligibility & Minimum Qualification in Medical Institutions Regulations 2022 / OMES rules 2021 in force.

- 4.3 In case of non-medical teacher, the candidate must possess the PhD degree or any other qualification in the concerned subject as may be prescribed by NMC/MCI as the case may be from time to time.
- 4.4 Must have valid up to date medical registration along with registration of additional qualifications under any State Council of Medical Registration (Permanent Registration) after obtaining the degree.
- 4.5 Must have completed **Basic Course in Medical Education** from institution designated by NMC.
- 4.6 Must have completed **Basic Course in Biomedical Research.**
- 4.7 All qualifications as on the date of interview shall be considered.
- 4.8 **Selection Process:** Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
- 4.9 Weightage for teaching experience: 5 marks per year of experience as Asst. Professor from MCI/NMC/ permitted or recognized institutions.
- 4.10 Weightage for research publications: 5 marks per publication; (publication as per norm of NMC shall be considered).
- 4.11 In case of tie, it will be resolved as follows: In case of tie "the elderly, candidates shall be placed higher in rank to the younger."

4.12 **AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

- 5.2 Must have eight years of post PG experience including three years of teaching experience as Associate Professor in the concerned discipline in any MCI/ NMC permitted/ recognized institute with research publications of 04 numbers With at

least 02 as Associate professor as per MCI / NMC Teachers Eligibility & Minimum Qualification in Medical Institutions Regulations 2022 / OMES Rule 2021 in force.

- 5.3 Must have any other qualification as may be prescribed by NMC.
- 5.4 Must have valid up to date medical registration of additional qualifications under any State Council of Medical Registration (Permanent Registration) after obtaining the degree.
- 5.5 Must have completed **basic course in Medical Education** from institution designated by NMC.
- 5.6 Must have completed. Basic Course in Bio-Medical Research
- 5.7 **Selection Process:** Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of candidate:-
- 5.8 Weightage for teaching experience: 5 marks per year of experience as Assoc. Professor from MCI/NMC/ permitted or recognized institutions.
- 5.9 Weightage for research publications: 5 marks per publication; (publication as per norm of NMC shall be considered).
- 5.10 In case of tie, it will be resolved as follows: In case of tie, "the elderly candidates shall be placed higher in rank to the younger."

1. SELECTION PROCESS:

Eligible candidates shall appear personally before the Convener as per schedule and submit the application form attached to this advertisement duly filled in and self-attested photocopy of required documents and color passport photograph. They must bring the original documents for verification. After successful verification of the documents a provisional merit list shall be prepared and notified inviting any grievance to the merit. The grievances if any will be examined and a final merit list will be notified. The candidates will submit the signed option form for confirmation of their acceptance of allotment. The appointment order will be uploaded in website. Any other related information if required shall be notified by the Convener in the website.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.
