

TERMS AND CONDITIONS FOR SUBSCRIPTION TO JOURNALS FOR CENTRAL LIBRARY, JAJATI KESHARI MEDICAL COLLEGE & HOSPITAL, JAJPUR FOR THE YEAR 2025-26

1. Journals on order are to be supplied within 30 days after its publication. Failing which the purchase order will stand automatically cancelled. The EMD will be forfeited. Part supply will not be entertained.
2. Journals are to be supplied in good condition. Only original prints are to be supplied. No prints of photocopy shall be acceptable.
3. Prices of the journals are to be charged correctly in accordance with the publisher's latest catalogue price.
4. The selection of the firm will be made on the basis of highest discount @% rate as well as final price after discount and fulfilling the terms & conditions of the Tender.
5. A copy of the recent publisher's catalogue of the supplied journals is to be submitted along with the triplicate copy of journal invoices. Internet price proof if needed by the library will also be supplied.
