- 2. Journals are to be supplied in good condition. Only original prints are to be supplied. No prints of photocopy shall be acceptable.
- 3. Prices of the journals are to be charged correctly in accordance with the publisher's latest catalogue price.
- 4. The selection of the firm will be made on the basis of highest discount @% rate as well as final price after discount and fulfilling the terms & conditions of the Tender.
