- (i) The Contractual candidates shall draw the remuneration against the post in which they are posted in MCH at remuneration as may be notified by the Govt. from time to time.
- (ii) Any additional incentive as may be notified by Govt. for the said post, shall also be applicable.
- (iii) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 3 years.
- (iv) The selected candidates are requested to join within 7 days before the Dean & Principal of concerned institution
- (v) Other terms and conditions as mentioned in the Govt. Resolution no. 18582/H dt. 13.08.2020 shall be applicable.

Terms & Conditions for Inservice Candidates:

- (i) The engagement shall be purely temporary and on year to year tenure basis and may be for a maximum period of 3 years.
- (ii) The Regular In-service candidates shall be allowed to draw salary from the post against which they are posted in MCH, along with the additional incentive as notified by Govt. for the said post, shall also be applicable.
- (iii) Other terms and conditions as mentioned in the Govt. Resolution no. 18582/H dt. 13.08.2020 shall be applicable.
- (iv) The selected candidates are requested to join immediately before the Dean & Principal of concerned institution after being relieved from their present place of posting.
