## **RECRUITMENT FOR FILLING UP OF VACANT POSTS OF PROFESSOR / ASSOCIATE PROFESOR IN JK MCH JAJPUR**

Eligible candidates are invited to attend the Walk in Interview for the post of Professor / Associate Professors in JK MCH JAJPUR on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack, either on contractual /deputation basis are eligible to apply for the next higher post. The regular faculties of any Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

### **1. AVAILABLE VACANCY**

The vacancy is provisional and is subject to change as on the date of counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The detailed vacancy shall be notified in the website.

### **2. ELIGIBILITY:**

2.1 The candidate must be a citizen of India.

2.2 Qualification:

#### **2.2.1 ASSOCIATE PROFESSOR**

2.2.1.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.

- 2.2.1.2 Must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI/ NMC permitted / recognized institute with research publications as per MCI/NMC guidelines / OMES rule 2021 in force.
- 2.2.1.3 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical/ Dental Registration after obtaining the degree.
- 2.2.1.4 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.1.5 Must have completed basic course in Bio-Medical Research.

**2.2.2 PROFESSOR:**

- 2.2.2.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty.
- 2.2.2.2 In case of non-availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.
- 2.2.2.3 Must have teaching experience of minimum 3 years as Associate Professor in the concerned discipline in any MCI/ NMC permitted/ recognized institute with research publications as per MCI / NMC guidelines/ OMES Rule 2021 in force.
- 2.2.2.4 Must have any other qualification as may be prescribed by NMC.

- 2.2.2.5 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.
- 2.2.2.6 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.2.7 Must have completed basic course in Bio-Medical Research.

### **3. AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

### **4. PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener as per programme to be notified, in the o/o DMET Odisha, at 11.00 AM and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e.[www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

## **5. PROCEDURE OF SELECTION**

- a. Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
  - i. Weightage for teaching experience: 5 marks per year of experience as Asst. Professor/ Assoc. Professor from MCI/NMC/ permitted or recognized institutions.
  - ii. Weightage for research publications: 5 marks per publication; (publication as per norm of NMC shall be considered).
- b. In case of tie, it will be resolved as follows:
  - i. In case of tie the elderly candidates shall be placed higher in rank to the younger.”
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- e. All communication shall be made through the website of DMET, Odisha i.e [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) No Postal/ personal communication will be made.
- f. Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in). The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

## **6. TERMS AND CONDITIONS**

All the terms and conditions as per Govt. letter issued from time to shall be applicable.

- a. The Contractual Professors are entitled for remuneration of Rs. 2,30,000/- per month. The Contractual Associate Professors are entitled for remuneration of Rs. 2,00,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt letter No. 9684/H Dt 02.05.2022.

- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice from either side.
- d. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
- e. Selected candidates have to register themselves in Odisha Council of Medical Registration within one month and sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
- f. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.

- x. No Objection Certificate from Non Odisha Govt. Employer/Authority
- xi. Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter I card/,AADHAR card
- xii. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
