RECRUITMENT FOR FILLING UP OF POSTS OF ASSOCIATE PROFESSOR / ASST PROFESSOR SR/TUTOR IN GOVT MEDICAL COLLEGES AT BOLANGIR AND BALASORE, SLN MC KORAPUT & PRM MC MAYURBHANJ

ASSOCIATE PROFESSOR

Eligible candidates are invited for Walk in Interview for the post of Associate Professor in different disciplines in Govt. Medical Colleges at Bolangir and Balasore, SLN MC Koraput & PRM MC Mayurbhanj. The candidates shall be appointed on contractual basis. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview. The candidates working in State Government or who are already working as Assistant Professor/ Associate Professor in any of the Govt. Medical College of the state or VIMSAR Burla are not eligible to apply.

1. **AVAILABLE VACANCY**

Will be notified in the website of DMET, Odisha i.e. www.dmetodisha.gov.in

2. **ELIGIBILITY:**

2.1 Must have possessed P.G. degree in the concerned specialty.

2.2 Must have registered him/ herself under any State Medical Council /MCI after obtaining the MD/MS degree.

2.3 For the post of Associate Professors must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI permitted / approve /recognized institute with research publications as per MCI guidelines in force.

2.4 Candidates working as consultant after post graduation in the concerned disciplines in a 300 bedded hospital owned and managed by State Govt./Central Govt. are also eligible to apply subject to the condition that for the post of Associate Professor must have experience of more than 10 years in the concerned discipline with two Research publication in indexed journal as 1st Author or corresponding author.

3. **AGE LIMIT**

The upper age limit of candidates for appointment on contractual basis shall be 68 years as on 1.1.2018.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. **PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener on **10.04.2018, 10 AM** as per tentative schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents along with Bank Draft of Rs.500/- drawn in favor of Convener Selection Committee, DMET Odisha, payable at SBI HOD Branch, Bhubaneswar. They must bring the original documents for verification. After successful verification of the documents, a merit list shall be prepared and notified on the spot.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper may be initiated against him/her.

5. **PROCEDURE OF SELECTION**

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science (excluding 4th optional/extra optional marks) and 60% of total percentage of marks secured in all MBBS. One mark shall be deducted for each extra chance taken to pass.

Appointment will be on merit basis. Appointment order shall be issued on the same day. The candidate must report before the authority of the institution allotted within seven days and submit a copy of the appointment letter and signed agreement.

6. **TERMS AND CONDITIONS & REMUNERATIONS:**

6.1 The Contractual employees shall get remuneration as under:

Associate Professor Rs. 1, 00, 000/-pm + 3% hike per annum subject to satisfactory performance

In addition to the above, incentive at the following rate shall be allowed.

Further in addition to the above, the employee in Preclinical and Para-clinical departments shall get additional incentive of Rs: 20, 000/-pm.

6.2 The candidates on selection must submit an agreement in the prescribed format before joining. The agreement format will be available with the concerned Dean & Principal of the institution.

ASSISTANT PROFESSOR,

Eligible candidates are invited to Walk in Interview for the post of Assistant Professor in different disciplines in Govt. MC Balasore and Balangir, PRM MCH Mayurbhanj SLN MCH Koraput. The candidates working on regular basis under OMHS Cadre shall be appointed on deputation basis and get salary. The candidates without any such service shall be appointed on contractual basis with a remuneration of Rs.75,000/- per month. In addition the incentives as may be declared by Government shall be applicable. The candidates have to submit an application form attached to this advertisement dully filled-in in all respect at the time of walk in interview. Candidates, who are already working as Asst. Professor in any of the Govt. Medical Colleges of State of Odisha or VIMSAR Burla, are not eligible to apply.

1. Available vacancy

2. Eligibility:

2.1 Pre & Paraclinical disciplines:

- 2.1.1 Candidates possessing PG degree in the concerned specialty with three years of experience as Tutor from any permitted/approved/recognized Medical institution will be given 1st preference
- 2.1.2 Candidates possessing PG degree in the concerned specialty with one year of post PG experience as Tutor from any permitted/approved/recognized Medical Institution will be given 2nd preference.
- 2.1.3 Candidates possessing Medical M. Sc with Ph.D. in concerned discipline shall be given 3rd preference.

2.2 Clinical disciplines:

- 2.2.1 Candidates possessing PG degree in the concerned specialty with three years of experience as Senior Resident from any permitted/approved/recognized Medical institution will be given 1st preference
 - 2.2.2 Candidates possessing PG degree in the concerned specialty with one year of post PG experience as Senior Resident from any permitted/approved/recognized Medical Institution will be given 2nd preference.
 - 2.2.3 MBBS Degree holder possessing DNB degree with teaching experience as per MCI guidelines in force shall be given 3rd preference
- 2.3 Must have registered him/ herself under any State Medical Council /MCI after obtaining the MD/MS degree.

3. Age limit

The upper age limit for candidates on deputation basis, shall be less than 62 years as on 1.1.2018 and for contractual posting the upper age limit shall be less than 70 years as on 1.1.2018.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. Procedure of selection

- 4.1 All the eligible candidates who wish to participate in walk in interview shall appear personally before the DMET, Odisha, Heads of Departments Building, Bhubaneswar, 751001 (or as will be notified) along with original bank draft of Rs.500/- drawn in favor of Convener Selection

Committee, DMET, Odisha, payable at SBI HOD Building Branch Bhubaneswar, all required **documents in original and one set of photocopies on 10.04.2018. The reporting time is 10.00 AM. (Candidates without Original documents shall not be entertained)**

N.B.: *In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.*

- 4.2 Merit shall be on the basis of the marks secured i.e. 20% of HSC marks, 20% of +2 Science marks (excluding 4th optional/extra optional marks) and 60% of all MBBS/M.Sc. marks. One mark shall be deducted for each extra chance taken to pass examinations from HSC to MBBS/M.Sc.
- 4.3 The appointment order shall be issued on the same day on the basis of merit and choice of institution exercised.

5. **Miscellaneous conditions**

- 5.1 There will be no reservation policy as the posts are filled up temporarily and as the posts could not be filled up by OPSC in time.
- 5.2 The posts are purely temporary and the direct candidates cannot claim their right to continue in the post on the basis of such appointment. The direct candidates if employed anywhere other than State Government of Odisha must take prior permission from their appointing authority that if selected shall be relieved immediately to join the place of posting within seven days. **Selected Candidates on contractual appointment have to submit the duly filled in agreement form available in the website.**
- 5.3 Those who are serving under Odisha Medical Health Service cadre on regular basis shall apply directly to the DMET, Odisha under intimation to the controlling authority. The candidates on adhoc /contractual /temporary appointment in OMHS cadre, on selection can join after resigning from the post.
- 5.4 The tenure of such Assistant Professor appointed on deployment basis will be reverted to their parent cadre as and when the post of Asst. Professor will be filled up by regular Asst Professor.
- 5.5 The salary will be paid to the in-service doctors posted as Assistant Professor on the basis of exercising option for availing the salary of existing scale or scale of Assistant Professor.
- 5.6 Those selected from OMHS cadre will be allowed with protection of their existing pay in the parent cadre and will be allowed the higher of the GP/AGP of the post they join in. The service conditions will continue as it is as a State Government employee. At the time of reversion back to the respective parent cadre, their pay will be fixed as per Note 2 of Rule 79 (c) i.e. the presumptive pay-in the parent post will be considered towards increment for the period worked as Assistant Professor. To read otherwise, for all purposes they will be entitled to salary and allowances of the post they hold for the period they are put under.
- 5.7 In case the incumbent while in deployment retires/dies/ removed the pay which one would have been entitled had he continued in the original post shall be treated as last pay, for pension determination u/r 2 of Pension rules 1992.
- 5.8 All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.

SENIOR RESIDENTS/ TUTORS

Eligible candidates are invited to Walk in Interview for the posts of Senior Residents (SR)/ Tutors in different disciplines in Govt. MC Balasore and Balangir, PRM MCH Mayurbhanj SLN MCH Koraput. The applicant must have acquired the required qualification for the post applied for on or before the date of interview. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The posts are non-practicing. The in-service departmental candidates will be entitled for salary (usual regular pay and grade pay) and the direct candidates will be paid consolidated amount and any additional incentive that may be declared by the Government. Candidates who have already completed 3 years of SR/Tutor or continuing SR/Tutor in any Govt. Medical College of the State, need not apply.

1. **Available vacancy:**

The tentative vacancy is available in the website.

2. **Reservation:**

As per Govt decision the prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

3. **Age:**

Must be less than 39 years of date on the date of interview.

4. **Eligibility:**

- 4.1 A candidate must possess a MD/ MS/DNB degree in concerned discipline.
- 4.2 Qualifications as on the date of counseling shall be considered.
- 4.3 The candidate must be a citizen of India.
- 4.4 The candidates must have registered their Medical Qualification at Central/ State Medical Council and must possess up-to-date registration.

NB: The candidate whose service as SR has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for re-appointment.

5. **Procedure of selection**

5.1 All the eligible candidates who wish to participate in walk in interview shall appear before the DMET, Odisha, Heads of Departments Building, Bhubaneswar, 751001 (or as will be notified) along with original bank draft of Rs.500/- drawn in favor of “Convener Selection Committee, DMET, Odisha”, payable at SBI HOD Building Branch Bhubaneswar, all required **documents in original and one set of photocopies on 10.04.2018. The reporting time is 10.00 AM.**

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.

5.2 The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS (60%), Intermediate (20%) and HSC or equivalent (20%); One mark will be deducted from the accrued career mark for each extra attempt taken in any qualifying examination.

5.3 The Selection Authority at their discretion may short-list the candidates to a reasonable number.

5.4 In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject will be given a chance.
