## **RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSISTANT PROFESSOR IN GOVT MEDICAL COLLEGES**

Eligible candidates are invited to Walk in Interview for the post of Assistant Professor in Govt. Medical Colleges of the State on contractual basis in view of MCI urgency with due approval of the Deputy Chief Electoral Officer – cum – Deputy Secretary to Government Home (Election) Department. The details of eligibility criteria/ vacancies/ etc are as under. The candidates shall be appointed on contractual basis. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview. The candidates who are already working as Assistant Professor in any of the Govt. Medical College of the state, VIMSAR Burla or AHRCC Cuttack, either on contractual or regular basis are not eligible to apply.

### **2. ELIGIBILITY:**

- 2.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology, the candidates with Medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI, in force.
- 2.2 Must have teaching experience as per MCI guidelines in force.
- 2.3 Must have registered himself/ herself under any State Medical Council MCI after obtaining the degree.

### **3. AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on 17.4.2019. (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

### **4. PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener on 17.04.2019 at 10.00 AM at IMA House Bhubaneswar as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm>. [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in "Recruitment for Govt. Medical Colleges" section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

### **5. PROCEDURE OF SELECTION**

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS/ M.Sc.

Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in). The candidate must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order.

### **6. TERMS AND CONDITIONS & SALARY ETC**

All the terms and conditions as per Govt. Resolution No.5202/H. Dt. 26.02.2019 shall be applicable

- 6.1 The Contractual employees are entitled for remuneration of Rs. 75,000/- per month. In addition to the above, incentive at the rate of Rs.50,000/- per month at Balangir and Koraput & Rs. 15,000/- per month at Balasore and Mayurbhanj shall be allowed. Further in addition to the above, an additional incentive of Rs: 20, 000/-pm shall be allowed for serving in preclinical and paraclinical departments.
- 6.2 All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
