## **RECRUITMENT FOR FILLING UP OF ONE VACANT POST OF ASSISTANT PROFESSOR IN BIOCHEMISTRY AT SCB MC CUTTACK.**

Eligible candidates from regular OMHS cadre having more than five years of service are invited to Walk in Interview for one post of Assistant Professor in Biochemistry at SCB MCH Cuttack on deputation basis in view of MCI urgency with due approval of Deputy Chief Electoral Officer- cum -Deputy Secretary to Government (Home) Department. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview. The candidates who are already working as Assistant Professor in any of the Govt. Medical College of the state or VIMSAR Burla, either on contractual or regular basis are not eligible to apply.

### **1. AVAIALABLE VACANCY**

One post of Assistant Professor in department of Biochemistry, SCB MC Cuttack.

### **2. ELIGIBILITY:**

- 2.1 Must have possessed MD or equivalent degree in the concerned specialty or as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI, in force.
- 2.2 Must have registered himself/ herself under any State Medical Council MCI after obtaining the degree.

### **3. PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener on 15.4.2019 at 10.00 AM in the office of DMET, Odisha, Bhubaneswar as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

### **4. PROCEDURE OF SELECTION**

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS.

Engagement will be on the basis of merit. Appointment order shall be uploaded in the website of DMET, Odisha, i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) . The candidate must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order.
