#### 1. **ELIGIBILITY:**

- 1.1 Must have possessed P.G. degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology the TEQ criteria of MCI shall be followed.
- 1.2 Must have registered him/ herself under any State Medical Council/ Dental Council /MCI/ DCI after obtaining the MD/MS/MDS degree.
- 1.3 For the post of Associate Professors must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI/DCI recognized institute with research publications as per MCI/DCI guidelines in force.
- 1.4 For the post of Professors must have teaching experience of minimum 3 years as Associate Professor in the concerned discipline in any MCI/DCI recognized institute with research publications as per MCI/DCI guidelines in force.

#### 2. AGE LIMIT

The upper age limit for candidates on contractual basis shall be 70 years as on 1.1.2017.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

#### 3. PROCEDURE OF APPLICATION

Eligible candidates shall appear personally before the Convenor on the notified date and time as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. After successful verification of the documents a merit list shall be prepared and notified on the spot.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.

#### 4. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science (excluding 4th optional/extra optional marks) and 60% of total percentage of marks secured in all MBBS.

Appointment will be on merit basis. Appointment order shall be issued on the same day. The candidate must report before the authority of the institution allotted within seven days and submit a copy of the appointment letter.

#### 5. TERMS AND CONDITIONS & SALARY ETC

- 4.1 The applicants for posting on deputation basis will be selected in the following order.
  - 5.1.1 Central Govt. Employees under CGHS including Central Govt. PSUs.
  - 5.1.2 Other State Government Employees
- 4.2. There will be no reservation policy as the post are filled up temporarily and as the posts could not be filled up by OPSC in time.

- 4.3. The in-service applicants will join immediately on selection and obtain permission from the cadre controlling authority before appearing.
- 4.4. The doctors on deputation basis shall draw salary from their controlling authority.
- 4.5. The Contractual employees shall get remuneration as under:

Professor Rs. 1, 25, 000/-pm Associate Professor Rs. 1, 00, 000/-pm

In addition to the above, incentive at the following rate shall be allowed.

Bolangir & Koraput Balasore & Mayurbhanj Rs. 1, 25, 000/-pm Rs. 35,000/-pm Associate Professor Rs. 1, 00, 000/-pm Rs. 25,000/-pm

Further in addition to the above, the employee in Preclinical and Para-clinical departments shall get additional incentive of Rs: 20, 000/-pm

- 4.6. The appointment of the Associate Professor or Professor appointed on contractual basis will be temporary and can be terminated at any time with one month prior notice.
- 4.7. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment.
- 4.8. The terms and conditions as prescribed in the Odisha Service Code will be applicable for inservice candidates.
- 4.9. The pay of the employees working in the CGHS/ other State Governments/ PSUs will be protected on production of Last Pay Certificate.
- 4.10. Those, selected for the posts from outside the state will be under deployment on Foreign ' Service terms and conditions. They will be guided by the standard terms of deployment as per FD OM dtd.02.12.1962. If salary is not paid by their authorities they shall be paid as per the contractual remuneration at clause 4.5 above.
- 4.11. In case the-incumbent while in deployment retires/dies/ removed the pay which one would have been entitled had he continued -in the original post shall be treated as last pay, for pension determination u/r 2 of Pension rules 1992.
- 4.12. Since the above arrangement is for administrative convenience and it is not a deployment to foreign body there shall be no contribution towards leave, pension etc.
- 4.13. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
