# ADVERTISEMENT FOR ENGAGEMENT OF NON-TEACHING STAFF IN GOVT. MEDICAL COLLEGES OF THE STATE

Applications are invited from eligible candidates for the following non-teaching posts at different Govt. Medical Colleges of the state on contractual basis. The eligible candidates are requested to apply online by logging in to the website of DMET, Odisha i.e. <a href="www.dmetodisha.gov.in">www.dmetodisha.gov.in</a>. The procedure of application, selection and other eligibility are as under.

The applicant must have acquired the required qualification for the post applied for on or before the counseling date. The engagement shall be purely temporary in nature. The candidates shall be entitled for a monthly remuneration as mentioned against the post.

#### 2. <u>AGE:</u>

He / she must not be less than 21 years and must not be above 32 years of age as on the date of advertisement. The upper age limit will be relaxed by 5 years for ST, SC, SEBC & Women candidates and by 10 years for Physically Challenged candidates. Relaxation may be allowed to Ex Servicemen candidates as per prevailing rules. Candidates having more than one category shall be allowed benefit of relaxation in one category only.

The candidates engaged on contractual basis in similar assignment under H & F.W. Deppt. under the Central Plan Schemes, State Plan Schemes and externally aided Schemes against the post duly approved by Health & F.W Deppt. & concurred by Finance Dept. and below the age of 45 years and have completed at least one year of continuous service shall be allowed to take part in the recruitment process as per the G.A Deptt. # 4. **OTHER ELIGIBILITY CONDITIONS**:

4.1 The candidate must be a citizen of India.

- 4.2 The Medical Graduates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration) or have deposited the required fees to obtain Registration Certificate from the respective council. However they must produce the registration before joining the institution.
- 4.3 Candidates having post graduation in any discipline are not eligible to apply.
- 4.4 The candidates who have already completed three years JR/ Senior Resident/Tutor in any MCI recognized institute in the country are not eligible to apply

#### 5. RESERVATION:

The prevalent reservation policy of the state government will be applicable. As these are tenure posts, in case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

### 6. PROCEDURE OF APPLICATION

- 6.1 All the eligible candidates who wish to participate in counseling procedure for must **register** in due time in the website of DMET i.e. www.dmetodisha.gov.in in Assistant Professor section. Registration means creating own username and password for logging in to the online counseling site. Without registration the candidate cannot proceed to next step of online application. The user name and password must not be shared with others. The detail schedule will be available in the website of DMET, Odisha.
- 6.2 After log-in to the site the candidate has to fill up the **online application** form and submit by clicking the "submit" button. A printout of the online application form must be taken.
- 6.3 The candidate has to attend the **document verification** session and get his/her online application authenticated. In case of emergency any authorized person on behalf of the candidate can attend on production of authorization letter of candidate. The candidate has to submit the counseling/application fees, of Rs. 100/- in shape of bank draft drawn in favour of "Convenor Selection Committee, DMET, Odisha", payable at Bhubaneswar from any SBI, and self attested copies of documents along with originals. The counseling/application fee is not refundable. Only on successful verification of documents the candidate becomes eligible and name will appear in the merit list. The names of candidates who fail to attend document verification on scheduled dates will not appear in the merit list.

**N.B.:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.

6.4 Institution will be allotted on merit basis. The candidate can download the **allotment letter** and appointment letter will be issued by concerned Dean & Principal.

Candidates must be in touch with the website of DMET, Odisha i.e. <a href="www.dmetodisha.gov.in">www.dmetodisha.gov.in</a> for all notifications. If required a physical counselling may be done for allotment of institutions.

# 7. PROCEDURE OF SELECTION

Selection shall be on the basis of merit determined through career marks mentioned against each of the post above.

# 8. <u>MISCELLANEOUS CONDITIONS</u>:-

- 8.1 Be a domicile of State of Odisha.
- 8.2 Be of Good Character.
- 8.3 Be of Sound Health, good physique and free from organic defects or bodily infirmity.
- 8.4 Have not more than one spouse living, if married.
- 8.5 Appointment is purely on contract basis and may be terminated any time without assigning any reason thereof.

- 8.6 The selected candidates will have to undertake that they will not claim any financial benefits other than the monthly remuneration (Pay & G.P) which they will receive.
- 8.7 In case of non-availability of Women candidates the vacancy will be filled up by eligible male candidates of the respective category.
- 8.8 Candidates appointed on contractual basis will not claim for inter Medical College/District transfer.
- 8.9 The authority reserves the right to cancel this advertisement at any time without assigning any reason thereof.
