

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Eligible candidates have to submit an application form attached to this advertisement dully filled in all respect along with legible copy of all documents in a single pdf file, and submit to the email id- dmetodisharecruitment1@gmail.com on or before 18.11.2020 by 5.00 PM. Applications incomplete or received late will be rejected. They must show the original documents for online verification. After successful online verification of the documents, a merit list shall be prepared and notified. 5. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS. One % mark shall be deducted for each extra chance taken.
