## **RECRUITMENT FOR FILLING UP OF POSTS OF SENIOR RESIDENTS IN VIMSAR BURLA**

Eligible candidates are invited for walk-in interview for selection of the posts of Senior Residents (SR) in different disciplines in VIMSAR, Burla. The applicant must have acquired the required qualification for the post applied for on or before the date of counseling. The engagement order will be issued by the competent authority of the institution. The posts are non-practicing. The in-service departmental candidates will be entitled for salary (usual regular pay and grade pay) and the direct candidates will be paid consolidated amount of Rs. 65, 000/- (Rupees Sixty five Thousand only) for SR/ Tutors per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Candidates, who have already completed 3 years of SR or continuing in such posts in any Govt. Medical College of the State, need not apply.

### **1. Available vacancy:**

The provisional vacancy is subject to change with prior notice.

*NB: the above vacancies for Asst Prof, SR, Tutor and JR are provisional. In view of MCI urgency the vacancy status may be updated and will be notified. The vacancy status notified by the date of counseling shall be final. All the candidates are requested to check the vacancy status before exercising option for college and subject. The Senior Residents in the disciplines of Neurosurgery, Plastic Surgery, General Surgery, Radiology, Orthopedic Surgery and Anaesthesiology shall work in Trauma Care Facilities attached to the Medical Colleges on rotation basis.*

### **2. Reservation:** Vacancy based reservation will be applicable as per the guidelines of Govt.

### **3. Age:**

- Must be less than 45 years as on the date of joining in the post for SR.

### **4. Eligibility & Qualification:**

- For the post of Senior Residents in Clinical Departments the candidate must possess MD/MS/MDS/DNB or any Equivalent Degree in concerned discipline applied for, or as may be prescribed by Medical Council of India /NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998" notified or amended from time to time in force.
- In case of superspecialty disciplines a candidate must have qualification of DM/M.Ch degree in concerned discipline. In-case of non-availability of DM / M.Ch. candidates,

the MD in Medicine and MS in General Surgery can be considered but their Senior Resident ship will be counted in the concerned superspecialty subject only and not in broad specialty.

- c. All Qualifications as on the date of counseling shall be considered.
- d. Other eligibility conditions:
  - i. The candidate must be a citizen of India.
  - ii. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI/NMC/DCI permitted/ approved /recognized Institute.
  - iii. The candidate whose service as Senior Resident has been terminated by any govt. Medical College in the state for whatsoever reason will not be considered for re-appointment.

**6. Selection Process:**

Eligible candidates have to submit an application form attached to this advertisement dully filled in all respect along with copy of all documents required and submit to the email id- dmetodisharecruitment@gmail.com on or before 2.10.2020 by 5.00 PM. Applications incomplete or received late will be rejected. They must show the original documents for online verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm>. [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. They have to submit the online payment reference slip along with the application form towards application fee. The application fee is not refundable under any circumstances. After successful online verification of the documents, a merit list shall be prepared and notified. Any other information as and when required shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in "Recruitment for Govt. Medical Colleges" section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

- a. Allotment shall be made on the basis of merit and choice. Engagement letter shall be issued in favour of allotted candidates by the Director, VIMSAR.
- b. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation-	20% of total percentage of marks secured.
Intermediate Science-	20% of total percentage of marks secured.
MBBS/M.Sc. examination-	60% of total percentage of marks secured.

One % mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

- c. In case of tie it will be resolved as follows: The candidate securing more mark in MBBS shall be placed in higher rank. In case of further tie the elderly candidates shall be placed higher in rank to the younger.

- d. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- e. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. All communication shall be made through the website of DMET, Odisha i.e [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) No Postal/ personal communication will be made.
- g. A panel list may be prepared by the committee on basis of merit which will remain valid for a period of one year from the date of its publication. In case any vacancy exists or arises against the notified vacancy in the advertisement, it shall be filled up from the panel list. (If additional vacancies are created which were not notified in the advertisement a separate selection process shall be done).
