RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSISTANT PROFESSOR IN GOVT MEDICAL COLLEGES OF STATE

Eligible candidates are invited to Walk in Interview for the post of Assistant Professor in Govt Medical Colleges of the State on contractual/deputation basis in view of MCI urgency. The details of eligibility criteria/ vacancies/ etc are as under. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis. The candidates who are already working as Assistant Professor in any of the Govt. Medical College of the state, VIMSAR Burla or AHRCC Cuttack, either on contractual /deputation or regular basis are not eligible to apply.

2. **ELIGIBILITY:**

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 The candidates must possess MD/MS/MDS/DNB Degree in the concerned discipline from any MCI permitted/approved/recognized Medical/Dental College and/or any other academic qualification with such additional teaching experience in the subject as may be prescribed by OMES Rule /MCI.

Candidates having three years of teaching experience as SR/Tutor/Registrar/Demonstrator as per OMES guidelines shall be given 1st preference. If sufficient candidates are not available, candidates having one year teaching experience as SR/Tutor/Registrar/Demonstrator shall be considered.

2.2.2 Candidates having M.Sc. (medical subjects) with Ph. D in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology subjects will be considered if sufficient candidates with PG degree/ DNB are not available and subject to the limitations as may be prescribed by MCI from time to time.

2.3 The Medical Graduates must have registered their Medical Qualification at Central/ State Medical Council (Permanent Registration)

2.4 The above qualifications must have been obtained on or before the date of counseling/ interview

3. **AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. **PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener in the o/o/ DMET, Odisha Bhubaneswar as per schedule (notified in website) and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS. One % mark shall be deducted for each extra chance taken.

Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. www.dmetodisha.gov.in . The candidate must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order.

6. TERMS AND CONDITIONS & SALARY ETC
