2. ELIGIBILITY:

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 The candidates must possess MDS or Equivalent Degree in the concerned specialty and must have teaching experience as Senior Resident as per DCI guidelines in force.

2.2.2 Post Graduation with three years experience as SR shall be given 1st Preference.

2.2.3 Post Graduation with experience as SR of 1 Year or more but less than 3 Years shall be given 2nd Preference.

2.2.4 Must have registered himself/herself under any State Dental Council after obtaining the Degree.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Eligible candidates shall appear personally before the Convener in the o/o/ DMET, Odisha Bhubaneswar as per schedule (notified in website) and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all BDS. One % mark shall be deducted for each extra chance taken.

Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. www.dmetodisha.gov.in . The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

- 6.1 The Contractual employees are entitled for remuneration of Rs. 75,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- 6.2 The in-service candidates shall be allowed usual salary and any incentive as may be notified by Govt.
