## **RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSISTANT PROFESSORS IN SCB DENTAL COLLEGE, CUTTACK**

Eligible candidates are invited to Walk in Interview for the post of Assistant Professors in SCB Dental College & Hospital, Cuttack on contractual/deputation basis in view of DCI urgency. The details of eligibility criteria/ vacancies/ etc are as under. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview. In view of DCI requirement any candidate who after being selected do not join or leave the job before completion of one year without prior approval of the appointing authority shall not be considered for subsequent advertisements for three years.

### **2. ELIGIBILITY:**

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 The candidates must possess MDS or Equivalent Degree from the DCI recognized/ approved/ permitted Dental Colleges/ Institutions in the concerned specialty and must have teaching experience in the concerned speciality as Senior Resident/ Tutor/ Demonstrator/ Lecturer/ Equivalent post as per DCI guidelines in force. The equivalency certificate of SR ship to be obtained from the respective authority of the concerned institution.

***N.B. Non submission of equivalency certificate will not be considered as SR ship for the post.***

2.2.2 Post Graduation with three years teaching experience shall be given 1<sup>st</sup> Preference.

2.2.3 Post Graduation with experience of 1 Year or more but less than 3 Years shall be given 2<sup>nd</sup> Preference.

2.2.4 Must have registered himself/herself under any State Dental Council after obtaining the Degree.

### **3. AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

### **4. PROCEDURE OF APPLICATION**

Eligible candidates shall appear personally before the Convener in the o/o/ DMET, Odisha Bhubaneswar as per schedule (notified in website) and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm> . [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

### **5. PROCEDURE OF SELECTION**

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all BDS. One % mark shall be deducted for each extra chance taken.

Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) . The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

### **6. TERMS AND CONDITIONS & SALARY ETC**

All the terms and conditions as per Govt. letter No. 6547/H Dt. 4.3.2017 & Resolution No.5202/H. Dt. 26.02.2019, shall be applicable.

6.1 The Contractual employees are entitled for remuneration of Rs. 75,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.

6.2 The in-service candidates shall be allowed usual salary and any incentive as may be notified by Govt.
