RECRUITMENT FOR FILLING UP OF VACANT POSTS OF ASSISTANT PROFESSORS IN GOVT MEDICAL COLLEGES OF STATE

Eligible candidates are invited to Walk in Interview for the post of Assistant Professors in Govt Medical Colleges of the State on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis. The candidates who are already working as Assistant Professor in any of the Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack, either on contractual /deputation or regular basis are not eligible to apply. In view of MCI/ NMC requirement any candidate who after being selected do not join or leave the job before completion of one year without prior approval of the appointing authority shall not be considered for subsequent advertisements for three years.

1. AVAILABLE VACANCY

The vacancy will be notified in the website of DMET, Odisha i.e. www.dmetodisha.gov.in

NB: The vacancy is provisional and may change with prior notice.

2. ELIGIBILITY:

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 For Broad specialty disciplines must have possessed MD/MS/MDS/ DNB or equivalent degree in the concerned specialty and as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI/NMC, in force and must have teaching experience as per MCI and State Govt. guidelines in force. The candidates having three years of post PG (broad specialty) teaching experience as SR/Tutor/Registrar & Demonstrator from any permitted/approved/recognized institute by MCI shall be preferred to candidates with one year post PG (broad specialty) experience. In case of non availability of candidates with MD /MS /DNB in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology, the candidates with Medical M.Sc. with PhD qualification may be considered or as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI/NMC in force.

2.2.2 For superspecialty disciplines must have DM/M.Ch or equivalent degree in the concerned specialty and as per Teachers Eligibility Qualifications 1998 (latest amendments) of MCI /NMC, in force and must have teaching experience as per MCI and State Govt. guidelines in force.

2.2.2.1 Must have registered himself/ herself under any State Medical Council/ MCI after obtaining the degree.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

Eligible candidates have to submit an application form attached to this advertisement dully filled in all respect along with legible copy of all self attested documents required and submit to the email id-dmetodisharecruitment@gmail.com on or before 2.10.2020 by 5.00 PM. Applications incomplete or received late will be rejected. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm>. [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. They have to submit the online payment reference slip along with the application form towards application fee. The application fee is not refundable under any circumstances. After successful scrutiny of the documents, a merit list shall be prepared and notified. Any other information as and when required shall be notified by the Convener in the website of DMET, Odisha i.e. www.dmetodisha.gov.in in "Recruitment for Govt. Medical Colleges" section.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science and 60% of total percentage of marks secured in all MBBS. One % mark shall be deducted for each extra chance taken.

Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. www.dmetodisha.gov.in. The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

6. TERMS AND CONDITIONS & SALARY ETC

All the terms and conditions as per Govt. letter No. 6547/H Dt. 4.3.2017 & Resolution No.5202/H. Dt. 26.02.2019, along with the following conditions shall be applicable.

- 6.1 The Contractual employees are entitled for remuneration of Rs. 75,000/- per month.
- 6.2 The in-service candidates shall be allowed usual salary and any incentive as may be notified by Govt.
- 6.3 All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.

- 6.4 The candidates who after being selected do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
