## **CORRIGENDUM ADVERTISEMENT**

In pursuance of the Govt. In Health & FW Department letter No. 25125/H Dt. 9.10.2017 and in accordance to the Minimum Qualification of Teachers in Medical Institutions Regulations 1998 (Amended up to 8<sup>th</sup> June 2017), the advertisement for recruitment of SR/Tutor and faculties are modified and the detail revised / modified advertisement are as under. The candidates who had applied earlier for the post of SR/Tutor/ Asst Professor in conformity with the present eligibility criteria, need not apply. The recruitment for contractual Associate Professor and Professor is held up for time being.

# RECRUITMENT FOR FILLING UP OF POSTS OF ASSISTANT PROFESSOR IN GOVT MEDICAL COLLEGES AT BOLANGIR, BALASORE, KORAPUT (SLN MC) & MAYURBHANJ (PRM MC) ON DEPLOYMENT/ CONTRACTUAL BASIS

Online applications are invited from eligible candidates for recruitment to the post of Assistant Professor in different disciplines in Govt. Medical College Bolangir, Balasore, Koraput and Mayurbhanj. The details of eligibility criteria/ vacancies/ terms and conditions etc are as under. The candidates working under OMHS Cadre / Assistant Professors working in PSUs/ other State Government/ Central Government shall be appointed on deputation basis. The candidates without any such service shall be appointed on contractual basis and will get remuneration as per Govt. norms. The candidates who are already working as Assistant Professor in any of the Govt. Medical /Dental College of the state or VIMSAR, Burla are not eligible to apply. The candidates who have applied earlier and gone through the document verification as per the earlier advertisement No. 11655 Dt. 16.09.2017 need not apply again.

### 1. AVAILABLE VACANCY

The tentative vacancy position will be notified later. The vacancy list is provisional.

#### 2. ELIGIBILITY:

- 2.1 Must have possessed P.G. degree in the concerned specialty with three year's experience as Tutor/ Senior Resident from any MCI recognized Medical Institution and they will be given 1st preference.
- 2.2 In case of non availability of such candidates the "Candidates with PG Degree and one year of teaching experience in the subject as Senior Resident/ Tutor in a recognized Medical College, in the subject" shall be given 2<sup>nd</sup> preference.
- 2.3 Candidates having only PG degree without any teaching experience as SR/Tutor or MBBS Degree holder possessing DNB degree shall be given 3<sup>rd</sup> preference. The DNB qualification shall be considered at par to MD/MS as per MCI guidelines.

- 2.4 Candidates having M.Sc. (medical subjects) in Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology subjects only are also eligible but will be considered if sufficient candidates with PG degree/ DNB are not available.
- 2.5 All candidates except M.Sc. in medical subjects must have registered him/ herself under any State Medical Council/ Dental Council after obtaining the MD/MS/MDS degree.

### 3. AGE LIMIT

The upper age limit for candidates on deputation basis, shall be 62 years as on 1.1.2017 and for contractual posting the maximum age up to which a person can be appointed shall be 70 years

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

## 4. PROCEDURE OF SELECTION (Online)

All the eligible candidates who wish to participate in counseling procedure for admission must register in due time in the website of DMET i.e. www.dmetodisha.gov.in in appropriate sections. Registration means creating own username and password for logging in to the online counseling site. Without registration the candidate cannot proceed to next step of online application. The user name and password must not be shared with others.

After log-in to the site the candidate has to fill up the online application form and submit by clicking the "submit" button. A printout of the online application form must be taken.

The candidate has to attend the document verification session and get his/her online application authenticated. In case of emergency any authorized person on behalf of the candidate can attend on production of authorization letter of candidate. The candidate has to submit the counseling/application fees, of Rs. 500/- in shape of bank draft drawn in favour of "Convenor Selection Committee, DMET, Odisha", payable at SBI, HOD Building Branch, Bhubaneswar, and self attested copies of documents along with originals. The counseling/application fee is not refundable. Only on successful verification of documents the candidate becomes eligible and name will appear in the merit list. The names of candidates who fail to attend document verification on scheduled dates will not appear in the merit list. N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected

Appointment will be on merit basis. The candidate shall personally appear before the Convener on the notified date, time and venue for receiving appointment order.

and disciplinary /legal action as deemed proper will be initiated against him/her.

The candidate must report before the authority of the institution allotted with in stipulated date as notified and submit a copy of the provisional appointment letter for completion of appointment process at institutional level.

Selection shall be on the basis of the marks secured i.e. 20% of HSC marks, 20% of +2 Science marks (excluding 4th optional/extra optional marks) and 60% of all MBBS marks.

### 5. TERMS AND CONDITIONS & SALARY ETC

- 5.1 The applicants for posting on deputation basis will be selected in the following order.
  - 5.1.1 Central Govt. Employees under CGHS including Central Govt. PSUs.
  - 5.1.2 Other State Government Employees
  - 5.1.3 Employees of Government of Odisha under Odisha Medical Service (OMS) cadre.
- 5.2. There will be no reservation policy as the post are filled up temporarily and as the posts could not be filled up by OPSC in time.
- 5.3. The in-service applicants on selection will join immediately and are deemed to be relieved from his / her former post on such joining. Those who are serving under Odisha Medical Service cadre shall apply directly to the DMET, Odisha (online) under intimation to the cadre controlling authority.
- 5.4. The salary will be paid to the in-service doctors posted as Assistant Professor on the basis of exercising option for availing the salary of existing scale or scale of Assistant Professor.
- 5.5. The tenure of Assistant Professor appointed on deployment basis will be reverted to their parent cadre as and when the post of Asst. Professor will be filled up by regular Asst Professor.
- 5.6. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. In view of anticipation of claim by the Asst. Professor, they will give an undertaking to this effect.

- 5.9. Those selected from OMHS cadre will be allowed with protection of their existing pay in the parent cadre and will be allowed the higher of the GP/AGP of the post they join in. The service conditions will continue as it is as a State Government employee. At the time of. reversion back to the respective parent cadre, their pay will be fixed as per Note 2 of Rule 79 (c) i.e. the presumptive pay-in the parent post will be considered towards increment for the period worked as Assistant Professor. To read otherwise, for all purposes they will be entitled to salary and allowances of the post they hold for the period they are put under .

- 5.10. Those, selected for the post of Assistant Professor from outside the OMHS cadre will be under deployment on Foreign 'Service terms and conditions. They will be guided by the standard terms of deployment as per FD OM did.02.12.1962.
- 5.11. In case the-incumbent while in deployment retires/dies/ removed the pay which one would have been entitled had he continued -in the original post shall be treated as last pay, for pension determination u/r 2 of Pension rules 1992.
- 5.12. The Contractual employees shall get remuneration as under:

Assistant Professor Rs. 60,000/-pm

In addition to the above, incentive at the following rate shall be allowed.

Bolangir/Koraput Balasore/Mayurbhani

Assistant Professor Rs. 50,000/-pm Rs. 15,000/-pm Further in addition to the above, the employee in Preclinical and Para-clinical departments shall get additional incentive of Rs: 20, 000/-pm

- 5.13. Since the above arrangement is for administrative convenience and it is not a deployment to foreign body there shall be no contribution towards leave, pension etc.

# RECRUITMENT FOR FILLING UP OF POSTS OF **SR\TUTOR** IN GOVT MEDICAL COLLEGES AT **BOLANGIR**, **BALASORE**, **KORAPUT** (**SLN MC**) & **MAYURBHANJ** (**PRM MC**)

Online applications are invited from eligible candidates for recruitment for the posts of Senior Residents (SR)/ Tutors in different disciplines in Govt. Medical Colleges of the State at Bolangir, Balasore, Koraput & Mayurbhanj. The candidates who are already working as SR/Tutor in any Govt. Medical Colleges of state or VIMSAR Burla, are not eligible to apply. The candidates who have applied earlier and gone through the document verification as per the earlier advertisement No. 11655 Dt. 16.09.2017 need not apply again. However the candidates who have applied earlier in anumber of subjects for the post of Tutor in a single application form can apply afresh with DD of Rs 500/- for each additional subject..

The applicant must have acquired the required qualification for the post applied for on or before the date of counselig. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The posts are non-practicing. ### 2. RESERVATION:

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

## 3. <u>AGE:</u>

- 3.1 He / she must not be above 35 years of age as on 01.01. 2017 for direct candidates and he/she must not be above 40 years of age as on 01.01.2017 for in-service candidates.
- Further the upper age limit will be relaxed by 5 years in respect of the candidate belonging to SEBC / Woman/ST/SC / Ex. Serviceman & for 10 years in respect of candidate belonging to PH (Physically Challenged category) as on 1st January 2017. The same candidate cannot avail relaxation on more than one criterion simultaneously.

- 4.2.2 (M.Sc qualification in medical subjects is applicable for Anatomy, Physiology, Biochemisty, Pharmacology, & Microbiology only).
- 4.3 Qualifications as on the date of counseling shall be considered.
- 4.4 If a candidate claims to possess any qualification equivalent to the prescribed qualification, the guiding rule/ letter of authority must be furnished with the application form.

- 6.6 The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS/ BDS (60%), Intermediate (20%) ( excluding 4th optional/extra optional marks) and HSC or equivalent (20%); One mark will be deducted from the accrued career mark for each case of failure/ extra attempt taken in any qualifying examination.
- 6.7 The Selection Authority at their discretion may short-list the candidates to a reasonable number.
- 6.8 In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject will be given a chance.
