**Instructions to Candidates: (In accordance with the orders of Hon'ble Apex Court,**

**Guidelines of GoI & MCI)**

1. Any candidate who has taken admission in All India Counseling and has joined will not be allowed in any further counseling. (Candidates taken admission in All India Counseling are not allowed to surrender the seat and cannot participate in 2<sup>nd</sup> round / spot counseling of the state.)
2. The admission fees as per earlier notification will be applicable.
3. The admissions of Sarada Prasanna Pradhan will be subject to outcome of WPC No. 3463 of 2018.
4. All the eligible candidates as per the merit list of the state, published by the Convener are eligible to take part in counseling.
5. Before the counseling the candidates have to fill in their choices again.
6. After choice filling allotment will be made as per their rank.

7. In case a candidate has already taken admission under State Quota and is participating in the 2nd round counseling for a better seat/college then if he takes admission in a seat as per new choice filling then the earlier admission will stand cancelled. The candidates are requested to fill in only better choices than previous admission. Candidates should not fill in all choices available.
8. Candidates are requested to keep copies of all allotment cum admission letters with them for future reference.
9. For new admissions the Fees, CLC and other documents mentioned in the allotment cum admission letter are required to be submitted.
10. In case of changing of admission between Govt. and Hi-tech Medical college occurs the differential fees shall be collected or returned as the case may be.
11. In case any seat remains vacant at the end of 2nd round counseling, it will be filled up in a spot counseling which will be notified.
12. The Seat Matrix for the spot counseling shall be notified in the venue of spot counseling.
