## **RECRUITMENT FOR FILLING UP OF VACANT POSTS OF PROFESSOR/ASSOCIATE PROFESSOR/ASSISTANT PROFESSOR IN VIMSAR, BURLA, SLN MCH, KORAPUT, PRM MCH, BARIPADA & MJKMCH, JAJPUR**

Eligible candidates are invited to attend the Walk-in-Interview for the post of Professor/Associate Professor/Assistant Professor in VIMSAR, Burla, SLN MCH, Koraput, PRM MCH, Baripada & MJKMCH, Jajpur on contractual/deputation basis in view of NMC urgency. The details of eligibility criteria, vacancies etc. are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the State, VIMSAR, Burla or AHRCC, Cuttack either on contractual/deputation basis are eligible to apply for the next higher post. The regular faculties of any Govt. Medical College of the State, VIMSAR, Burla or AHRCC, Cuttack are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

### **1. AVAILABLE VACANCY**

The vacancy is provisional and is subject to change as on the date of counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The detailed vacancy shall be notified in the website of DMET, Odisha.

### **2. ELIGIBILITY**

2.1 The candidate must be a citizen of India.

2.2 Academic qualifications, teaching experience and other requirements:

#### **2.2.1 ASSISTANT PROFESSOR**

2.2.1.1 Must have possessed MD/MS/DNB/MDS (for Broad Specialties) and DM/M.Ch/DNB SS/DrNB (for Super Specialties) or equivalent degree in the concerned subject from any MCI/NMC recognized/permitted Medical College/DCI recognized/permitted Dental College or any other academic qualification with such additional teaching experience in the concerned subject as may be prescribed by the NMC and as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

2.2.1.2 In case of non-availability of candidates with MD/MS/DNB or equivalent degree in Anatomy, Physiology, Biochemistry, Pharmacology & Microbiology, candidates with Master of Science in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology with Doctor of Philosophy in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology may be considered, if such qualification is obtained through a regular, in-campus course from a recognized medical institution and with such additional experience in the concerned subject as per 'Medical Institutions (Qualification of Faculty)

Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

2.2.1.3 The above qualifications must have been obtained on or before the date of counseling/walk-in-interview.

2.2.1.4 Must have valid up-to-date medical registration along with registration of additional qualification under any State Council of Medical/Dental Registration after obtaining the degree.

## 2.2.2 **ASSOCIATE PROFESSOR**

2.2.2.1 Must have possessed MD/MS/DNB/MDS (for Broad Specialties) and DM/M.Ch/DNB SS/DrNB (for Super Specialties) or equivalent degree in the concerned subject from any MCI/NMC recognized/permitted Medical College/DCI recognized/permitted Dental College as prescribed by NMC and as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

2.2.2.2 In case of non-availability of candidates with MD/MS/DNB or equivalent degree in Anatomy, Physiology, Biochemistry, Pharmacology & Microbiology, candidates with Master of Science in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology with Doctor of Philosophy in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology may be considered, if such qualification is obtained through a regular, in-campus course from a recognized medical institution as may be prescribed by NMC and as per the 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

2.2.2.3 Must have teaching experience of minimum four years as Assistant Professor (for Broad Specialties) and two years as Assistant Professor (for Super Specialties) in the subject in a MCI/NMC recognized/permitted institution or any other academic qualification with such additional teaching experience in the concerned subject as may be prescribed by the NMC with research publications and other requirements as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

2.2.2.4 Must have valid up-to-date medical registration along with registration of additional qualification under any State Council of Medical/Dental Registration as the case may be after obtaining the degree.

2.2.2.5 Must have completed Basic Course in Medical Education as per NMC Guidelines in force.

2.2.2.6 Must have completed Basic Course in Biomedical Research as per NMC Guidelines in force.

## 2.2.3 **PROFESSOR**

2.2.3.1 Must have possessed MD/MS/DNB (for Broad Specialties) and DM/M.Ch/DNB SS/DrNB (for Super Specialties) or equivalent degree in the concerned subject from any MCI/NMC

recognized/permitted Medical College as prescribed by NMC and as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.

- 2.2.3.2 In case of non-availability of candidates with MD/MS/DNB or equivalent degree in Anatomy, Physiology, Biochemistry, Pharmacology & Microbiology, candidates with Master of Science in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology with Doctor of Philosophy in Medical Anatomy/Medical Physiology/Medical Biochemistry/Medical Pharmacology/Medical Microbiology may be considered, if such qualification is obtained through a regular, in-campus course from a recognized medical institution as prescribed by NMC and as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.
- 2.2.3.3 Must have teaching experience of minimum three years as Associate Professor in the subject in a MCI/NMC recognized/permitted institution or any other academic qualification with such additional teaching experience in the concerned subject as may be prescribed by the NMC with research publications and other requirements as per 'Medical Institutions (Qualification of Faculty) Regulations, 2025' dated 30/06/2025 of NMC in force and OMES Rules, 2021.
- 2.2.3.4 Must have any other qualification as may be prescribed by NMC.
- 2.2.3.5 Must have valid up-to-date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.
- 2.2.3.6 Must have completed Basic Course in Medical Education as per NMC Guidelines in force.
- 2.2.3.7 Must have completed Basic Course in Biomedical Research as per NMC Guidelines in force.

### 3. **AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

### 4. **PROCEDURE OF APPLICATION**

Interested candidates shall fill up the google form in the link as mentioned in schedule as a pre-registration process to participate in the walk-in-interview. Without pre-registration the candidates will not be allowed to participate in walk in interview. Eligible candidates shall appear in-person before the Convener as per the schedule notified; in the O/o DMET Odisha, at 11.00 AM and submit the application form attached to this advertisement duly filled-in and self-attested photocopy of all the required documents and a passport size color photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- is to be deposited online at <https://www.onlinesbi.com/sbicollect/icollecthome.htm>. [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /Recruitment fee]. Copy of the bank transaction receipt is to be submitted during document verification. After successful verification of the documents a merit list shall be prepared and

notified as per the schedule. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in “Recruitment for Govt. Medical Colleges” section.

N.B.: In case any candidate is found to have provided a false information or fake/forged certificate(s)/documents etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification/counseling/choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

## 5. **PROCEDURE OF SELECTION**

- i. Selection will be strictly on the basis of merit as per Notification No. 38346/H dated 30/12/2025 and Health & FW Department Resolution No. 8967 dated 25/04/2022.
- ii. **SELECTION PROCEDURE FOR ASSISTANT PROFESSOR**
  - a. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
    1. HSC/Matriculation- 20% of total percentage of marks secured.
    2. Intermediate Science- 20% of total percentage of marks secured.
    3. MBBS/BDS examination- 60% of total percentage of marks secured.  
(In case the candidate has passed PG in 2016/2017 or afterwards MBBS/BDS – 30% and PG – 30%)
  - b. One mark will be deducted from the total career mark for each extra attempt taken to pass the examinations.
  - c. In case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.
  - d. In case of tie, it will be resolved as follows:

The candidate securing more mark in MBBS/BDS shall be placed in higher rank.  
In case of further tie the elderly candidates shall be placed higher in rank to the younger.
- iii. **SELECTION PROCEDURE FOR ASSOCIATE PROFESSOR**
  - a. Must have academic qualification as prescribed by MCI/DCI from time to time in force.
  - b. Teaching experience: 1 mark per year of experience (Maximum 5 Marks) as Asst. Professor from MCI/NMC/DCI permitted or recognized institutions.
  - c. Research Publication: 1 mark per publication; (Maximum 5 Marks) publication as per norm of NMC shall be considered.
  - d. Service in State Govt (OMHS Cadre): 1 mark per year of experience; (Maximum 5 Marks).
  - e. In the event that two candidates secure equal marks, the candidate with greater teaching experience shall be selected.
  - f. If both candidates have the same marks and an equal number of years of teaching experience, the candidate who is senior in age shall be selected.
- iv. **SELECTION PROCEDURE FOR PROFESSOR**
  - a. Must have academic qualification as prescribed by MCI/DCI from time to time in force.
  - b. Teaching experience: 1 mark per year of experience (Maximum 5 Marks) as Associate Professor from MCI/NMC/DCI permitted or recognized institutions.

- c. Research Publication: 1 mark per publication; (Maximum 5 Marks) publication as per norm of NMC shall be considered.
- d. Service in State Govt (OMHS Cadre): 1 mark per year of experience (Maximum 5 Marks)
- e. In the event that two candidates secure equal marks, the candidate with greater teaching experience shall be selected.
- f. If both candidates have the same marks and an equal number of years of teaching experience, the candidate who is senior in age shall be selected.
- v. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- vi. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- vii. All communication shall be made through the website of DMET, Odisha i.e., [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in). No Postal/personal communication will be made.
- viii. Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of DMET, Odisha, i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in). The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

## 6. **TERMS AND CONDITIONS**

All the terms and conditions as per Govt. letter issued from time to time shall be applicable.

- a. The Contractual Professors are entitled for remuneration of Rs.2,30,000/- per month. The Contractual Associate Professors are entitled for remuneration of Rs.2,00,000/- per month. The contractual Assistant Professors are entitled for remuneration of Rs.1,20,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time-to-time.
- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one-month prior notice from either side.
- d. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.
- e. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
- f. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
- g. Any addendum or corrigendum if required shall be notified by DMET Odisha, which shall be a part of the advertisement.
