After careful consideration, the Government have been pleased to modify the guideline i.e. Inspection and compliance at item No-VI of the procedure for issue of NOC for different Nursing. Paramedical and Allied Medical Science Courses issued vide this Department Notification No-26601, dated-22.10.2019 to the following extent:-

Existing guidelines at point-VI i.e. Inspection and Compliances

The Inspection shall be conducted by a team of inspectors selected from pool of enlisted afficials to be prepared at the State level by the Department, who will assest the propertion team headed by ADM " Sub Collector/ FD DRDA of the Administration concerned District Further one Medical Officer of the district short be included in the term. The term will read at the physical verification of minimum regularizations for the concerned Jours in a Standard Inspection Formal that must be notified by concerned council. DMET from time to now

Partial modification in the guidelines Inspection and Compliances at item No-VI

The inspection shall be conducted by a team of inspectors selected from pool of enlisted officials to be prepared by the Chairman of the concerned Council. The team will conduct the physical verification of minimum requirement for the concerned course in a transparent manner, to be recorded in Standard Inspection Format that may be notified by the concerned Council / DMET from time to time.
