# GUIDELINES

FOR SIX MONTHS TRAINING IN ULTRASONOGRAPHY

## “FUNDAMENTALS OF ABDOMINO-PELVIC ULTRASONOGRAPHY: LEVEL ONE: FOR MBBS/PG(MD/MS)/DNB DOCTORS”

### A. INTRODUCTION:

Applications are invited from eligible MBBS/PG(MD/MS)/DNB doctors of state, for six months training in Ultrasonography namely “The Fundamentals of Abdomino-Pelvic Ultrasonography: Level One for MBBS/PG(MD/MS)/DNB doctors”, in Govt./accredited Medical Colleges of Odisha.

An Ultrasonography Selection Committee is constituted as under for selection of candidates for training. The members are:

The Committee will function in the office of the DMET, Odisha, and will carry out the following works.

- a. The Chairman will be the controlling & supervising authority and must see that the counseling and admission are done in strict conformity with the laws laid down.
- b. The Convener is authorized to float advertisements, convene meetings, and conduct selection and allotment of seats strictly as per the guidelines. He is the custodian of all documents including vouchers of expenditure of counseling process and will produce them as and when required. The expenditures will be made as per approved guidelines of Govt. He will file affidavits in all legal matters.

### B. ELIGIBILITY:

1. The candidate must have passed MBBS/ PG (MD/MS) / DNB from any MCI/NMC recognized institution and have been registered under any State Council of Medical Registration or MCI/NMC.

2. The candidate must be a permanent resident of Odisha.
3. The age shall be below 65 years.

### C. CATEGORY OF CANDIDATES

There will be two category of candidates namely Direct & In-service. 50% of total seats will be reserved for in-service candidates.

1. A **Direct Candidate** is one who at the time of application is either unemployed or if under employment of Government of Odisha/PSU, not completed 3 years' of service which includes all categories of employment like contractual/ temporary / ad-hoc/ regular by **31/03/2024**.
2. An **In-service** candidate is one who at the time of application is under employment in Government of Odisha/Govt. of Orissa Public Sector Undertakings/Govt. of India Public Sector Undertakings located in Odisha and has completed a length of 3 years of service including contractual, temporary, or ad-hoc or regular by **31/03/2024**., excluding at-a-stretch leave of any kind, of 30 days or more. However the maternity leave is exempted from this exclusion and shall be counted towards the length of three years of service.

### D. NAME OF THE COURSE:

The name of the six months training in Ultrasonography course shall be "The Fundamentals of Abdomino-Pelvic Ultrasonography: level one for MBBS/ PG (MD/MS) / DNB Doctors"

### E. DURATION OF THE TRAINING:

The duration of the training shall be six months with minimum of 300 hours. Training will be done under the supervision of HOD Radiology (or HOD O & G if Radiology is not available) and he/she will be the training coordinator. The theory and practical classes will be taken both in Radiology and O & G Departments.

### F. NAME OF ACCREDITED INSTITUTIONS FOR TRAINING:

The following institutions are accredited for such training.

Training will be imparted in the department of Radiology and O & G of above institutions.

N.B: Any other institution if subsequently accredited by Govt. will also be included for training.

**NB:** Intake of candidates will be on basis of 1:4 PG teacher –student ratio. The PG teachers of department of Radiology and O & G can be the faculty for such training. If subsequently the number of PG teacher is reduced due to any reason then the above intake capacity will be reduced. When the total seat is an odd number the distribution will be made good on rotation basis in subsequent year.

## H. RESERVATION

50% of total seats for MBBS/ PG (MD/MS) / DNB doctors will be reserved for candidates who are in State Govt./ State Govt. Undertakings service and have completed 3 years of service of any type (regular/ contractual/ adhoc/ temporary) excluding at a stretch leave of 30 days or more (except maternity leave). If seats in in-service category remain vacant, it will be filled up by Direct category candidates and vice versa.

## I. FEE STRUCTURE

The training fee shall be, Rs. 20,000/, to be deposited in the office of the Convener before joining.

## J. SUBMISSION OF APPLICATION

Candidates shall fill up the online google form available in the link <https://forms.gle/GMzMvomxtcL1jwbL9> on or before 07/03/2024 by 5.00 PM. Without pre-registration the candidates will not be allowed to participate in document verification. They shall download the application form annexed in this prospectus and submit duly filled in application along with all requisite documents at the time of document verification. They have to deposit a sum of Rs. 1000/- in SBI Collect at <https://www.onlinesbi.com/sbicollect/icollecthome.htm>. [under Odisha/Govt Department/ DMET Odisha, Convener Selection Committee /USG Appln fee]. and submit the online payment receipt/challan along with the application form towards application fee. The application fee is not refundable under any circumstances. Applications incomplete or received late will be rejected. After successful verification of the documents a merit list shall be prepared and notified. Any other information shall be notified by the Convener in the website of DMET, Odisha i.e. [www.dmetodisha.gov.in](http://www.dmetodisha.gov.in) in Ultrasonography section.

## **K. SELECTION**

Selection of doctors for the USG Training shall be made strictly on the basis of career marks @ HSC - 20%, +2SC - 20% and MBBS - 60% and the choice of institution opted.

## **L. EVALUATION & CERTIFICATE**

On completion of six months training the candidates have to appear for a competency based evaluation (final examination). On successful completion of the evaluation a certificate to the effect will be issued by the DMET, Odisha. Such certificates will be applicable for obtaining new registration /renewal under the PC&PNDT Act in all States.

## **O. MISCELLANEOUS**

- In all matters relating to eligibility or otherwise of a candidate for undergoing training, the decision of the Chairman Selection Committee shall be final.
- The candidates who are serving under Govt./Govt. undertakings and will undergo such training, the period of training will be treated as duty and salary will be paid.
- No stipend will be paid during the training period.
- The candidates are to abide by the rules and regulations of the institution.
- During training hours private practice of any kind is strictly prohibited. If anybody is found to be indulged in such activities, legal action as deemed proper will be taken against him/her.
- Candidates must have 95% attendance in training for appearing in the final competency based evaluation.
- Any addendum or corrigendum if required shall be notified by the Chairman which will be a part of this prospectus.
