NOTICE FOR SPOT ROUND (30.11.2019)

In view of many seats lying vacant a spot counselling shall be held on 30.11.2019 as per the programme detailed below.

Date: 30.11.2019 (9 AM Onwards)

Venue: 2nd floor DHS Conference hall, Bhubaneswar

Eligibility to participate: All the merit listed Candidates for 2nd batch of two years PG Diploma Program and Newly Registered Candidates (on 30.11.19) are allowed to participate for Spot Round.

Eligibility criteria for the fresh candidates are given below:

To be eligible a candidate must have passed MBBS from an MCI recognized institution and must have the following criteria:

1. A candidate must be a permanent resident of Odisha.
2. A candidate must have appeared in NEET PG-2019 with the following qualifying conditions: New score will be decided after adding 30 percent (%) of the score secured in the NEET-PG 2019 with the secured score. [e.g.: 300(NEET score) +90(30% of NEET score) =390 is the new score.] The new score should be equal to or above the qualifying cut-off score of 211 set by the MOH&FW for admission into the Diploma Courses.
3. At the time of application, she/he must be employed under the Dept. of Health and Family Welfare Government of Odisha and has completed a length of five (5) years of service including contractual, temporary, or ad-hoc, (under department of H & FW Govt. of Odisha) by 31st March, 2019, provided that at the time of application the candidates must be in regular service and must have at least 10 years of service in hand before superannuation.
4. Candidates who have completed or undergoing P.G. (Medical) Course in any subject shall not be eligible to participate in the counseling process.
5. Must have registered himself/ herself under State/ Central Council of Medical Registration.
6. Must have completed one year of Compulsory Rotatory Internship/ Houseman ship by 31st March 2019
