RECRUITMENT FOR FILLING UP OF POSTS OF JUNIOR RESIDENTS (NON-ACADEMIC) IN GOVT MEDICAL COLLEGES AT BOLANGIR, BALASORE, SLN MC KORAPUT & PRM MC BARIPADA.

(Approved vide Govt. letter No. 31892 /H Dt. 18.12.2017)

Eligible candidates are invited to Walk in Interview for the post of Junior Residents (JR Non- Academic) in Govt. Medical Colleges of the State at Bolangir, Balasore, SLN MC Koraput & PRM MC Baripada. The details of eligibility criteria/ vacancies/ terms and conditions etc are as under. The candidates have to submit an application form attached to this advertisement duly filled in all respect at the time of walk in interview. The candidates who are already appointed as Junior Resident in any Government Medical Colleges of the State through recruitment process need not apply.

The applicant must have acquired the required qualification for the post applied for on or before the counseling date. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The candidate who are already in State Government service will be entitled for salary and direct candidates shall be appointed on contractual basis with a monthly remuneration of Rs.55,000/-. In addition their service shall be counted for award of additional weightage in marks secured in NEET PG while determining the merit for admission to PG course under state quota seats as per the list of remote or backward areas notified in PG Medical/Dental guidelines.

2. AGE:

He / she must not be above 35 years of age as on 01.01. 2017.

3. QUALIFICATION:

- 3.1 A candidate must possess a MBBS/BDS degree or equivalent degree recognized by MCI/DCI.
- 3.2 The candidate must have completed the compulsory one year rotating internship.
- 3.3 The above qualifications and requirement must be obtained on or before the date of counseling.

4. OTHER ELIGIBILITY CONDITIONS:

- 4.1 The candidate must be a citizen of India.
- 4.2 The Medical/Dental Graduates must have registered their Medical/Dental Qualification at Central/ State Medical/Dental Council. (Permanent Registration)
- 4.3 Candidates having post graduation in any discipline are not eligible to apply.
- 4.4 The candidates who have already done three years JR in any MCI/DCI recognized institute in the country are not eligible to apply
- 4.5 The candidates must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI/DCI recognized Institute.

5. RESERVATION:

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

The upper age limit will be relaxed by 5 years for ST, SC & Women candidates, by 3 years for SEBC candidates and by 10 years for Physically Challenged candidates.

6. PROCEDURE OF APPLICATION

Eligible candidates shall appear personally before the Convener on the notified date and time as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification. After successful verification of the documents a merit list shall be prepared and notified on the spot.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.

7. PROCEDURE OF SELECTION

Selection shall be on the basis of the % of marks secured i.e. 20% of total percentage of marks secured in HSC, 20% of total percentage of marks secured in +2 Science (excluding 4th optional/extra optional marks) and 60% of total percentage of marks secured in all MBBS/BDS.

Appointment will be on merit basis. Appointment order shall be issued on the same day. The candidate must submit the joining report and duly filled in declaration form of MCI at the spot and must report before the authority of the institution allotted within two days and submit a copy of the appointment letter.

- 8.7 Permanent Certificate of Registration for Medical Qualifications at Medical Council of India/ State Medical Council/Dental Council.
- 8.8 Service Certificate from competent authority for Govt. of Odisha employees;
- 8.9 Certificate from competent authority in support of Reservation;
- 8.10 Physically handicapped certificate;
- 8.11 Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter I card/AADHAR card
- 8.12 If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
