RECRUITMENT FOR FILLING UP OF POSTS OF JUNIOR RESIDENTS (NON-ACADEMIC) IN GOVT MEDICAL COLLEGES AT BOLANGIR, BALASORE, SLN MC KORAPUT & PRM MC BARIPADA.

(Approved vide Govt. letter No. 31892 /H Dt. 18.12.2017)

Online applications are invited from eligible candidates for recruitment for the posts of Junior Residents (JR Non- Academic) in Govt. Medical Colleges of the State at Bolangir, Balasore, SLN MC Koraput & PRM MC Baripada.

The applicant must have acquired the required qualification for the post applied for on or before the counseling date. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The posts are non-practicing. The candidate who are already in State Government service will be entitled for salary and direct candidates shall be appointed on contractual basis with a monthly remuneration of Rs.35,000/-. Any additional incentive if notified by Government shall also be applicable.

2. RESERVATION:

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

The upper age limit will be relaxed by 5 years for ST, SC & Women candidates, by 3 years for SEBC candidates and by 10 years for Physically Challenged candidates.

3. AGE:

He / she must not be above 35 years of age as on 01.01. 2017.

4. QUALIFICATION:

- 4.1 A candidate must possess a MBBS degree or equivalent degree recognized by MCI.
- 4.2 The candidate must have completed the compulsory one year rotating internship.

4.3 The above qualifications and requirement must be obtained on or before the date of counseling.

5. **OTHER ELIGIBILITY CONDITIONS:**

5.1 The candidate must be a citizen of India.

5.2 The Medical Graduates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration)

5.3 Candidates having post graduation in any discipline are not eligible to apply.

5.4 The candidates who have already done three years JR in any MCI recognized institute in the country are not eligible to apply

5.5 The candidates must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI recognized Institute.

6. **METHOD OF SELECTION (Online)**

6.1 All the eligible candidates who wish to participate in counseling procedure for recruitment must register in due time in the website of DMET i.e. www.dmetodisha.gov.in in appropriate sections. Registration means creating own username and password for logging in to the online counseling site. Without registration the candidate cannot proceed to next step of online application. The user name and password must not be shared with others.

6.2 After log-in to the site the candidate has to fill up the online application form and submit by clicking the “submit” button. A printout of the online application form must be taken.

6.3 The candidate has to attend the document verification session and get his/her online application authenticated. In case of emergency any authorized person on behalf of the candidate can attend on production of authorization letter of candidate. The candidate has to submit the counseling/application fees, of **Rs. 500/- in shape of bank draft drawn in favour of “Convenor Selection Committee, DMET, Odisha”, payable at SBI, HOD Building Branch, Bhubaneswar**, and self attested copies of documents along with originals. The counseling/application fee is not refundable. Only on successful verification of documents the candidate becomes eligible and name will appear in the merit list. The names of candidates who fail to attend document verification on scheduled dates will not appear in the merit list.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.

6.4 The Selection Authority at their discretion may short-list the candidates to a reasonable number.

6.5 Appointment will be made on merit basis. The candidate shall personally appear before the Convener on the notified date, time and venue for exercising their choice of institution and receiving appointment order.

6.6 The candidate must report before the authority of the institution to which appointed with in stipulated date as notified and submit a copy of the appointment letter.

6.7 In case the candidate appointed to a post, fails to join in time, the appointment shall be cancelled.

6.8 The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS (60%), Intermediate (20%) (excluding 4th optional/extra optional marks) and HSC or equivalent (20%); One mark will be deducted from the accrued career mark for each case of failure/ extra attempt taken in any qualifying examination.

- 6.9 All communication shall be made through the website of DMET, Odisha i.e www.dmetodisha.gov.in No Postal communication will be issued.
- 6.10 The other requirements like schedule dates, reservation etc. will be notified by convener in the website in due time.

7. **DOCUMENTS REQUIRED AT TIME OF VERIFICATION**

Original and a set of Self-attested photocopies.

- 7.1 One copy of down loaded online application form.
- 7.2 Original Bank Draft of Rs. 500/-
- 7.3 H.S.C./ Equivalent Certificate in support of age;
- 7.4 +2/ Equivalent Examination Certificate;
- 7.5 MBBS Pass Certificate;
- 7.6 Mark sheets in support of all the aforesaid examinations (i.e. from H.S.C. to MBBS) passed including fail marks.
- 7.7 Certificate indicating the chances taken to pass the MBBS degree.
- 7.8 Permanent Certificate of Registration for Medical Qualifications at Medical Council of India/ State Medical Council.
- 7.9 Service Certificate from competent authority for Govt. of Odisha employees;
- 7.10 Certificate from competent authority in support of Reservation;
- 7.11 Physically handicapped certificate;
- 7.12 Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter I card/,AADHAR card
- 7.13 If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
