No. HFW-MEII-MISC-0084-2024- 25039 /H&F.W. Dated 26.08.2025

Government after careful consideration has been pleased to decide for inclusion of 19 (nineteen) ESI Hospitals/ Dispensaries as per the list in Annexure-A under Labour & Employee's State Insurance Department, Odisha located in remote/ vulnerable areas of the State in the PG Medical Admission Guidelines of Health & Family Welfare Department for the purpose of granting eligible additional weightage under Para-H of aforesaid guidelines for admission in post graduate medical courses.

This provision shall be applicable to the in-service Insurance Medical Officers (IMOs) who have joined service on or after 21.03.2016 subject to fulfilment of all eligibility criteria.

Further, the in-service candidates who joined service prior to 21.03.2016 shall be eligible for additional weightage at the rate of 10% for each completed year of service, subject to a maximum of 30% of the marks secured, to be added to the NEET-PG score of the candidate while determining the merit position as per Para-H of the Guidelines.

The DMET, Odisha is hereby directed to revise the guidelines accordingly.
