Subject: Constitution of State Allied and Healthcare Council under Section 22 of National Commission for Allied and Healthcare Professions Act, 2021

Dear Sir,

The Commission has been receiving clarifications from State Health Departments relating to the application of relevant Sections of the National Commission for Allied and Healthcare Professions Act, 2021 regarding constitution of State Allied and Healthcare Council to be constituted under Section 22 of the Act. A VC meeting was also held on 11.03.2024 with the representatives of some of the States and they were asked to constitute the State Council in proper manner before 24th May, 2024, the last date to constitute the State Councils as per notification dated 02.11.2024.

2. As per the provisions contained in para 22(3) of the Act the State Council shall consists of a Chairperson and the following Members-

1.	Chairperson	1	Qualifications and experience in the field of Allied and Healthcare Science/ profession as mentioned in para 22(3)(a) of the Act.	Nominated by the State Government
2.	Member	1	Director or Additional Director or Joint Director representing medical or health sciences in the State Government.	Ex-officio
3.	Member	2	Not below the rank of Dean or Head of the Department from any medical colleges of the State Government.	Ex-officio



4.	Member	4	President of the Autonomous Boards constituted by the State Council under sub-section (1) of section 29	Ex-officio
5.	Member	20	Two persons representing each of the recognised categories specified in the Schedule of the Act and having such qualifications and experience as may be prescribed by the State Government.	Nominated by the State Government
6.	Member	2	Two persons, representing charitable institutions engaged in education or services in connection with any recognised category, to be nominated by the State Government having such qualifications and experience as may be prescribed by the State Government.	Nominated by the State Government

- 3. It has been noticed that some of the State Councils have been constituted in deviation to the conditions as stipulated in Section 22(3) of the Act and such State Councils could not be considered as a valid Council under the Act. The Health Departments of respective States are requested to kindly rectify the deviations, if any, urgently.
- 4. The State Rules and Regulations under the Act should be framed only after notifying a valid Council constituted strictly as per the provisions of the Section 22 of the Act.
- 5. The State Councils already constituted under the Act are required to send the details of its chairperson and nominated members including their qualification and experience to the Secretary, NCAHP.
- 6. The State Councils already constituted under the Act are advised to provide details of its Bank Account for allotment of funds.

This is to bring to the kind notice of all Institutions, Organizations, Service providers, Professionals, Hospitals and Clinics in India and also the public at large that the National Commission for Allied and Healthcare Professions Act-2021 has been enacted by the Parliament of India and the National Commission for Allied and Healthcare Profession (NCAHP) has been constituted w.e.f from 08.01.2024.

The list of Professions coming under the purview of the Commission has been provided in the above Act and is available on the Ministry of Health and Family Welfare, Government of India website for reference (https://main.mohfw.gov.in/?q=cocuments/publication). The Commission is in the process of constituting various Special Committees to draft the Minimum Standards of "Registration Norms", "Practice Norms". "Institution Standards and Guidelines", "Professional Status", "Clinical Establishment Norms" and "Professional Ethics in respect of all professions covered under this National Commission for Allied and Healthcare Professions Act, 2021. Please note that all the decisions pertaining to the above mentioned Standards and Rules and Regulations, will be TAKEN BY THE NATIONAL COMMISSION FOR ALLIED AND HEALTHCARE PROFESSION (NCAHP). It may also be noted that ANY NOTIFICATION, decisions issued/circulated without the concurrence/consent of NCAHP, by any other Committee regarding the "Registration Norms", "Practice Norms", "Institution Standards and Guidelines", "Professional Status", "Clinical Establishment Norms and "Professional Ethics all professions covered under this National Commission for Allied and Healthcare Professions, including the Healthcare Professions like "Physiotherapy, Occupational Therapy, Optometry, Physician Associates and Nutrition Scientists" etc.
