8. Compulsory Internship completion certificate / Tentative completion certificate.
9. Permanent / Renewal Medical Registration Certificate.
10. Certificate in support of Reservation (if claimed).
11. Service certificate from CDMO or appropriate authority (for all Direct & In-service) candidates who are under any employment in State Govt. (Service certificates for any contractual period is subject to verification.)
12. Sponsoring letter from appropriate authority (PSU candidates).

Any document if found to be false/forged/manipulated/unauthentic/ the candidature will be cancelled and legal action as deemed proper shall be initiated against the candidate.
