2. The Balance Amount of Admission Fees against Management Quota, as may be notified by the Govt., shall be deposited by the Candidates at the level of the Institution.

INSTRUCTIONS FOR SECOND ROUND COUNSELING & ADMISSION

- 1. Any Candidate who has taken admission and joined in All India Counseling will not be allowed to participate in Second and Spot Rounds of State Counseling.
- 2. The Admission Fees and Documents Required for Admission are the same as that notified for the First Round Admission (See Website–Instructions for First Round Adm).
- 3. In case of Change of Admission between Govt. and Hi-Tech Medical College, the differential fees shall be collected or returned (as the case may be).

- 4. All Eligible Candidates as per the published Merit List are eligible to participate in Counseling.
- 5. Before the Counseling the Candidates have to fill in their choices again, as per the fresh Seat Matrix published.
- 6. The Allotment will be done as per the rank.
- 7. In case a Candidate has already taken admission under State Quota and is participating in the Second Round for a better seat/college, then if he takes admission in a seat as per the new choice filling, then the earlier admission will stand cancelled. The candidates are requested to fill in only better choices than previous admission (and not all available choices).
- 8. Candidates are requested to keep copies of all Allotment cum Admission Letters with them for future reference.
- 9. In case any Seat remains vacant at the end of Second Round Counseling, it will be filled up by Spot Counseling which will be notified.
- 10. The Seat Matrix of Spot Counseling will be notified at the venue of Spot Counseling.
