Dated the 16/1/17

Consequent upon amendment of sub-section(4) of Section 4 of VIMSAR Act, 2014, all teachers belonging to Odisha Medical Education Service Cadre(OMES Cadre) may exercise their options within a period of one month w.e.f. the date of issue of this order to become the teachers of Veer Surendra Sai Institute of Medical Sciences & Research, Burla.

Teachers who will not exercise their options shall be treated as teachers of OMES Cadre and those who are serving in VIMSAR, Burla shall continue as such on deputation basis till a suitable post is available in other Medical College & Hospitals under the State Government. The Assistant Professors, recruited on the recommendation of the Odisha Public Service Commission, Cuttack pursuant to Advertisement No-15 of 2015-16 for SCB Medical College & Hospital, Cuttack and MKCG Medical College & Hospital, Berhampur may also exercise their option for the purpose.

The Assistant Professors recruited pursuant to Advertisement No-17 of 2015-16 for VIMSAR, Burla need not exercise their option as they have been recruited solely for VIMSAR, Burla.

The seniority of the faculties in respective disciplines will be determined on the basis of seniority in the respective disciplines. Date of Birth and station seniority if more than one teacher of the cadre of VIMSAR, Burla exercise option to serve the institution.

Teachers of OMES Cadre shall furnish their option to become a teacher of the Institute in the following format to the Dean & Principals/ Superintendents of the concerned Medical College & Hospitals.
