WALK IN INTERVIEW FOR FILLING UP OF VACANT POSTS OF ASSISTANT PROFESSOR/ ASSOCIATE PROFESSOR/ PROFESSOR, SR/ TUTOR IN PANDIT RAGHUNATH MURMU MEDICAL COLLEGE & HOSPITAL, BARIPADA, MAYURBHANJA AND SAHEED LAXMAN NAYAK MEDICAL COLLEGE & HOSPITAL KORAPUT.

## A. ASSISTANT PROFESSOR/ASSOCIATE PROFESSOR/PROFESSOR

Eligible candidates are invited to Walking in Interview for the post of Assistant Professor/Associate Professor/Professors in different disciplines in PRM MCH Baripada, Mayurbhanja & SLN MCH Koraput. The details of eligibility criteria/ vacancies/ terms and conditions etc are as under. The candidates working under OMHS Cadre / Assistant Professors working in PSUs/ other State Government/ Central Government shall be appointed on deputation basis. The candidates without any such service shall be appointed on contractual basis. The candidates have to submit an application form attached to this advertisement dully filled in all respect at the time of walk in interview.

# 1. AVAILABLE VACANCY

The tentative vacancy position is notified separately

#### 2. **ELIGIBILITY:**

## **Assistant Professor**

- 2.1 Must have possessed P.G. degree in the concerned specialty with three year's experience as Tutor/ Senior Resident from any MCI recognized Medical Institution and they will be given 1st preference. In case of non availability of such candidates the eligibility criteria is "Candidates with three years of teaching experience in the subject as Resident/ Tutor in a recognized Medical College, either during P.G. course or after obtaining P.G. degree in the subject" as per the Medical Council of India Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998 (Amended up to 13th July 2016) OR
- 2.2 MBBS Degree holder possessing DNB degree from a MCI recognized institute along with three years of teaching experience in the subject from a recognized Medical college after obtaining the Diplomate National degree or possessing DNB degree from institutions other than MCI recognized Medical College/ Central Institute along with five years of teaching experience in the subject from a recognized Medical College after obtaining the Diplomate National Board degree.
- 2.3 In case of non-availability of MS/MD candidates M.Sc. qualified candidates as prescribed by the MCI will be appointed in the Department of Anatomy, Physiology, Pharmacology and Microbiology to the extent of 30% and in the Department Bio-Chemistry to the extent of 50% of the total number of posts.
- 2.4 Must have registered him/ herself under any State Medical Council /MCI after obtaining the MD/MS degree.

# Associate Professor /Professor

2.5 For the post of Associate Professors must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI recognized institute. For post of Professors must have teaching experience of minimum 3 years as Associate Professor in the

concerned discipline in any MCI recognized institute. Candidates for the post of Associate Professor and Professor must have research publications as per MCI guidelines in force

## 3. AGE LIMIT

the upper age limit for candidates on deputation basis, shall be 62 years as on 1.1.2017 and for contractual posting the upper age limit shall be 70 years as on 1.1.2017.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

## 4. PROCEDURE OF SELECTION

4.1. All the eligible candidates who wish to participate in walk in interview shall appear before the DMET, Odisha, Heads of Departments Building, Bhubaneswar, 751001 (or as will be notified) along with all required documents in original and two sets of photocopies on 25.04.2017. The reporting time is 11.00 AM.

**N.B.:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.

- 4.2. College and discipline will be allotted on merit basis.
- 4.3. Selection shall be on the basis of the marks secured i.e. 20% of HSC marks, 20% of +2 Science marks (excluding 4<sup>th</sup> optional/extra optional marks) and 60% of all MBBS marks.

# 5. TERMS AND CONDITIONS & SALARY ETC

- 5.1 The applicants for posting on deputation basis will be selected in the following order.
  - 5.1.1 Central Govt. Employees under CGHS including Central Govt. PSUs.
  - 5.1.2 Other State Government Employees
  - 5.1.3 Employees of Government of Odisha under Odisha Medical Health Service (OMHS) cadre.
- 5.2. There will be no reservation policy as the post are filled up temporarily and as the posts could not be filled up by OPSC in time.
- 5.3. The in-service applicants will join immediately on selection and obtain permission from the cadre controlling authority before appear. Those who are serving under Odisha Medical Service cadre shall apply directly to the DMET, Odisha under intimation to the controlling authority.
- 5.4. The salary will be paid to the in-service doctors posted as Assistant Professor on the basis of exercising option for availing the salary of existing scale or scale of Assistant Professor.
- 5.5. The tenure of such Assistant Professor appointed on deployment basis will be reverted to their parent cadre as and when the post of Asst. Professor will be filled up by regular Asst Professor.

- 5.6. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. In view of anticipation of claim by the Asst. Professor, they will give an undertaking to this effect.
- 5.7. The terms and conditions as prescribed in the Odisha Service Code will be applicable for inservice candidates.
- 5.8. The pay of the employees working in the CGHS/ other State Governments/ PSUs will be protected on production of Last Pay Certificate.
- 5.9. Those selected from OMHS cadre will be allowed with protection of their existing pay in the parent cadre and will be allowed the higher of the GP/AGP of the post they join in. The service conditions will continue as it is as a State Government employee. At the time of reversion back to the respective parent cadre, their pay will be fixed as per Note 2 of Rule 79 (c) i.e. the presumptive pay-in the parent post will be considered towards increment for the period worked as Assistant Professor. To read otherwise, for all purposes they will be entitled to salary and allowances of the post they hold for the period they are put under.
- 5.10 Those, selected for the post of Assistant Professor from outside the OMHS cadre will be under deployment on Foreign 'Service terms and conditions. They will be guided by the standard terms of deployment as per FD OM did.02.12.1962.
- 5.11. In case the-incumbent while in deployment retires/dies/ removed the pay which one would have been entitled had he continued -in the original post shall be treated as last pay, for pension determination u/r 2 of Pension rules 1992.
- 5.12. Since the above arrangement is for administrative convenience and it is not a deployment to foreign body there shall be no contribution towards leave, pension etc.
- 5.13. In case of exigency a candidate may be selected as Assistant Professor against the vacant post of Associate Professor or Professor. On subsequent appointment of Associate Professor or Professor the Assistant Professor so adjusted shall be adjusted against some other available posts. If no vacancy is available the Assistant Professor will be reverted bak to his original cadre.
- 5.14. All the communications shall be made through the website of DMET, Odisha and no personal communication shall be made.

#### **B. SENIOR RESIDENT / TUTOR**

Eligible candidates are invited to Walking in Interview for the posts of Senior Residents (SR)/ Tutors in different disciplines in PRM MCH Baripada, Mayurbhanja & SLN MCH Koraput as per the guideline laid down by the government of Odisha, Health and Family Welfare Department, Bhubaneswar, vide resolution number 1314/H dated 11/01/2013 and corrigendum issued vide letter number 5756/h dated 19/02/2013.

The applicant must have acquired the required qualification for the post applied for on or before 31/03/2017. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The posts are non-practicing. The in-service departmental candidates will be entitled for salary (usual regular pay and grade pay) and the direct candidates will be paid consolidated amount of Rs.50,000/- (Rupees Fifty Thousand only) per month or as decided by the government of Odisha.

## 1. AVAILABLE VACANCY:

The tentative vacancy position will be notified separately.

#### 2. RESERVATION:

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

### 3. **AGE**:

- a. He / she must not be above 35 years of age as on 1st January 2017 for direct candidates and she must not be above 40 years of age as on 1st January 2017 for in-service candidates.
- b. Further the upper age limit will be relaxed by 5 years in respect of the candidate belonging to SEBC / Woman/ST/SC / Ex. Serviceman & for 10 years in respect of candidate belonging to PH (Physically Challenged category) as on 1st January 2017. The same candidate cannot avail relaxation on more than one criterion simultaneously.

#### 4. QUALIFICATION:

- a. A candidate must possess a MD/ MS/ MDS degree in concerned discipline for Senior Resident post in clinical departments of broad specialties.
- b. In case of Pre/ Para clinical/ Dentistry disciplines, MBBS/ BDS is the basic qualification for the post of Tutor; however, preference will be given to MD/ MS/ MDS degree in concerned discipline.
- c. In case of non-availability of sufficient number of MBBS candidates, M.Sc. degree in Medical Anatomy/ Medical Physiology/ Medical Biochemistry/ Medical Pharmacology/ Medical Microbiology will be considered in respective discipline as prescribed by MCI.
- d. Qualifications as on the date of counseling shall be considered.
- e. If a candidate claims to possess any qualification equivalent to the prescribed qualification, the guiding rule/ letter of authority must be furnished with the application form.

#### 5. OTHER ELIGIBILITY CONDITIONS:

- a. The candidate must be a citizen of India.
- b. The Medical Graduates must have registered their Medical Qualification at Central/ State Medical Council
- c. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI recognized Institute.
- d. The candidate whose service as SR/Tutor has been terminated by any govt. medical college in the state for whatsoever reason will not be considered for re-appointment.

#### 6. METHOD OF SELECTION

- a. All the eligible candidates who wish to participate in walk in interview shall appear before the DMET, Odisha, Heads of Departments Building, Bhubaneswar, 751001 (or as will be notified) along with all required documents in original and two sets of photocopies on 25.04.2017. The reporting time is 11.00 AM.
  - **N.B.:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and appointment will be cancelled as the case may be and disciplinary /legal action as deemed proper may be initiated against him/her.
- b. The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS/ BDS/ M.Sc. (60%), Intermediate (20%) and HSC or equivalent (20%); One mark will be deducted from the accrued career mark for each case of failure/extra attempt taken in any qualifying examination.

- c. The Selection Authority at their discretion may short-list the candidates to a reasonable number.
- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject will be given a chance.
- e. All communication shall be made through the website of DMET, Odisha i.e www.dmetodisha.gov.in No Postal communication will be issued.
