Re-Advertisement for engagement of “Consultant- Examination” for OUHS, Bhubaneswar

Eligible candidates are invited for walk-in interview for selection of the post of Consultant in Odisha University of Health Sciences, Bhubaneswar of the State for a period of one year on contractual basis.

Whereas the Government of Odisha in Health & Family Welfare Department, has decided to engage one “Consultant – Examination” for the proposed Odisha University of Health Sciences, Bhubaneswar (In short OUHS) to prepare the Regulation, Manual, Scope for in-house End to End Automation of Examination Processes & Services for functionalization of the University for a period of one year The OUHS after establishment shall conduct Under-graduate, Masters (Broad Speciality) and Super Speciality degree courses in the field of medical and allied health sciences offered in the state of Odisha.

Whereas, the DMET, Odisha has been authorised to issue this advertisement for engagement of Consultant on the recommendation of the Search -Cum-Selection Committee meeting held on 03.03.2023. The procedure of engagement will be guided as per the provisions mentioned here under:

1. Eligibility, Qualification and Experience: The applicant must have minimum 15 years of teaching experience and must have worked in the similar position and cadre with a minimum period of five years' experience in a State affiliating University or Autonomous Institution. In addition, candidates having past experience of working in the same capacity as Controller / Director, Examinations in other University of Health Sciences / Universities / State or Central Government Autonomous Institutions offering health science courses will be given preference.
2. Age: Must be less than 66 years.
3. In-service (State / Central Government) candidates who are serving under OMHS cadre or any other cadre on regular basis are not eligible to apply as no protection of pay or whatsoever shall be allowed.
4. Procedure for application: Candidates shall be required to send their brief Resume on or before 5.00 PM 20.04.2023, and submit all supporting testimonials including proof of last organization served, Salary Certificate or Form-16, Valid Photo ID issued by the Govt. authorities i.e. Passport / PAN Card / Voter IdentityCard / AADHAR Card before the Walk – In- Interview by the Search-Cum- Selection Committee. Applications received after the stipulated time period shall not be entertained and summarily rejected.
5. The applications should be superscribed: Consultant- Examination, OUHS.
6. The candidate so selected along with the remuneration will be recommended by the Committee to the Govt. for its approval.
7. In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary / legal action as deemed proper will be initiated against him/her. At the time of document verification physical presence of the candidate is mandatory and no authorization will be entertained.
8. Terms and Conditions: (i) In case of termination, a period of one month notice will be given from either side, (ii) General instructions of Government regarding terms and conditions for contractual engagement as issued from time to time, will be applicable and binding to her / him, and (iii) S/he will be subject to and will abide by the Conduct Rules applicable to the Government Servant.
